IMPORTANT

Master gain control should be set at 10 when playing a distorted amplifier that will operate if master gain is at zero. Excessive master gain results in higher volume of overtones and produces distortion and overheat.

THIS MUSIC MAN 2 CHANNEL AMP IS EQUIPPED WITH A DUAL FUNCTION PHASOR FILTER SPEED CONTROL. SETS THE SPEED OF THE PHASOR SWEEP FROM VERY SLOW TO VERY FAST. WHEN THE KNOB IS PULLED OUT, THE AUTOMATIC SWEEP TURNS OFF AND YOU CAN ROTATE THE CONTROL TO MANUALLY SET THE PHASOR FILTERS WHERE YOU WANT THEM.
